Executive Summary

In 2020, nominal Gross Domestic Product (GDP) at current market prices increased across all zones¹, following a good performance in major economic activities, particularly construction, agriculture, transport and storage, manufacturing and mining. The increase was however, lower than in the preceding year owing to impact of COVID-19 pandemic on some economic activities especially accommodation and food services, arts, entertainment and recreation. Relatedly, nominal GDP per capita in all zones increased, led by Dar es Salaam zone.

As for inflation, the trend was mixed across zones. In 2020/21, average inflation edged up in Central, South Eastern and Southern Highlands zones and eased in Dar es Salaam, Lake and Northern zones. The slowdown in inflation in Dar es Salaam and Lake zones was on account of a fall in prices of some food items, mainly rice and maize, while the increase in Southern Highlands and South Eastern zones was driven by a rise in prices of some food items, especially beans.

Food supply across zones was satisfactory. Total food production increased by 3.9 percent to 18.4 million tonnes in 2020/21 compared to a requirement of 14.8 million tonnes resulting in a food Self-Sufficiency Ratio (SSR) of 125 percent. Accordingly, the stock of food held by the National Food Reserve Agency (NFRA) amounted to 107,357.4 tonnes versus 52,698 tonnes recorded in the previous year.

In terms of sectoral performance, the value of livestock sold increased by 28.6 percent. The outturn was partly associated with expanded markets in neighboring countries. As for fisheries, the value of fish sold in registered markets was lower than in the preceding year mainly explained by unfavorable weather conditions that affected fishing activities in major lakes due to rising water levels. Performance of manufacturing continued to register improvement with all zones recording an increase, except Lake zone. The performance was mostly underpinned by expansion of markets especially in neighboring countries.

¹ The Bank of Tanzania monitors economic developments at micro-level basing in six zones, each served by one branch office except Dar es Salaam which is monitored by Dar es Salaam sub-head office. The zones and representative regions are: Central zone which comprises Dodoma, Morogoro, Singida and Tabora regions; Dar es Salaam zone (Dar es Salaam region); South Eastern zone (Ruvuma, Coast, Lindi and Mtwara regions); Lake zone (Geita, Kagera, Kigoma, Mara, Mwanza, Shinyanga and Simiyu regions); Northern zone (Arusha, Kilimanjaro, Manyara and Tanga regions); and Southern Highlands zone (Iringa, Katavi, Mbeya, Njombe, Rukwa and Songwe regions).

Electricity generated domestically increased by 4.8 percent to 8,036,780.9 megawatts-hour (MWh), with all zones recording improvement. The increase was largely observed in thermal power plants in Dar es Salaam and Lake zones namely Kinyerezi II and Ubungo I; and Nyakato and Bukoba, respectively. Similarly, production of natural gas rose by 2.2 percent to 60,863.8 Million Standard Cubic Feet (MMSCF) from the volume registered in the preceding year, partly on account of increased demand by gas fired power plants operated by Tanzania Electric Supply Company Limited (TANESCO), manufacturing firms and households. Meanwhile, in the tourism sector, the number of visitors and earnings to attraction sites decreased by 38.0 percent and 20.5 percent, respectively, largely on account of measures taken to contain COVID-19 pandemic, which included travel restrictions.

The performance in revenue collection was good, albeit below the target. Central government tax revenue in 2020/21 was equivalent to 86.3 percent of the target. The outcome was mainly on account of underperformance in taxes on local goods and services. Meanwhile, collections by Local Government Authorities was TZS 711.1 billion, equivalent to 91 percent of the target. The increase was slightly higher than the preceding year partly explained by enhanced use of electronic payment systems. Port performance as measured by volume of cargo handled improved slightly. Specifically, the increase was recorded at Dar es Salaam, Tanga, Kilwa and Lindi seaports, largely associated with recovery of global supply chains which were disrupted by the outbreak of COVID-19 pandemic.

With respect to banks' operations, deposits grew across zones attributed to increased use of agent banking services and mobile banking platforms. Likewise, loans extended to various economic activities grew with personal and trade activities dominating the loan portfolio.

The outlook is promising as economic performance in all zones is expected to continue expanding in 2021/22, following rollout of COVID-19 vaccines country-wise, policy measures adopted by the Bank to increase credit to the private sector and lower lending rates, and ongoing strategic development projects and investments to support production activities.



1.0 ECONOMIC DEVELOPMENTS

1.1 Gross Domestic Product

During 2020, nominal Gross Domestic Product (GDP) increased across all zones, following a good performance in major economic activities, particularly, construction, agriculture, transport and storage, manufacturing and mining. Nominal GDP increased to TZS 148,522.1 billion from TZS 139,641.9 billion in the preceding year. The increase was however, lower than in the preceding year owing to impact of COVID-19 pandemic on some economic activities, especially accommodation and food services, arts, entertainment and recreation. Lake zone had the largest share in the country's nominal GDP at 26 percent, followed by Northern and Dar es Salaam zones (**Table 1.1**).

Correspondingly, all zones recorded an increase in nominal GDP per capita, with South Eastern zone registering the highest increase followed by Central and Dar es Salaam zones. With exception of Lake and Central zones, other zones had average nominal GDP per capita above the national average of TZS 2.7 million (**Table 1.2**).

1.2 Inflation Developments

During 2020/21, the trend of inflation was mixed across zones. Average headline inflation edged up in Central, South Eastern and Southern Highlands zones and eased in Dar es Salaam, Lake and Northern zones when compared with the year ending June 2020 (**Table 1.3** and **Chart 1.1**). The slowdown in inflation in Dar es Salaam and Lake zones was on account of a fall in prices of some food items, particularly rice and maize, while in Northern zone was due to a decline in prices of some non-food items, especially in restaurants and accommodation services group. An increase in inflation in Southern Highlands and South Eastern zones was driven by a rise in prices of some food items especially beans.

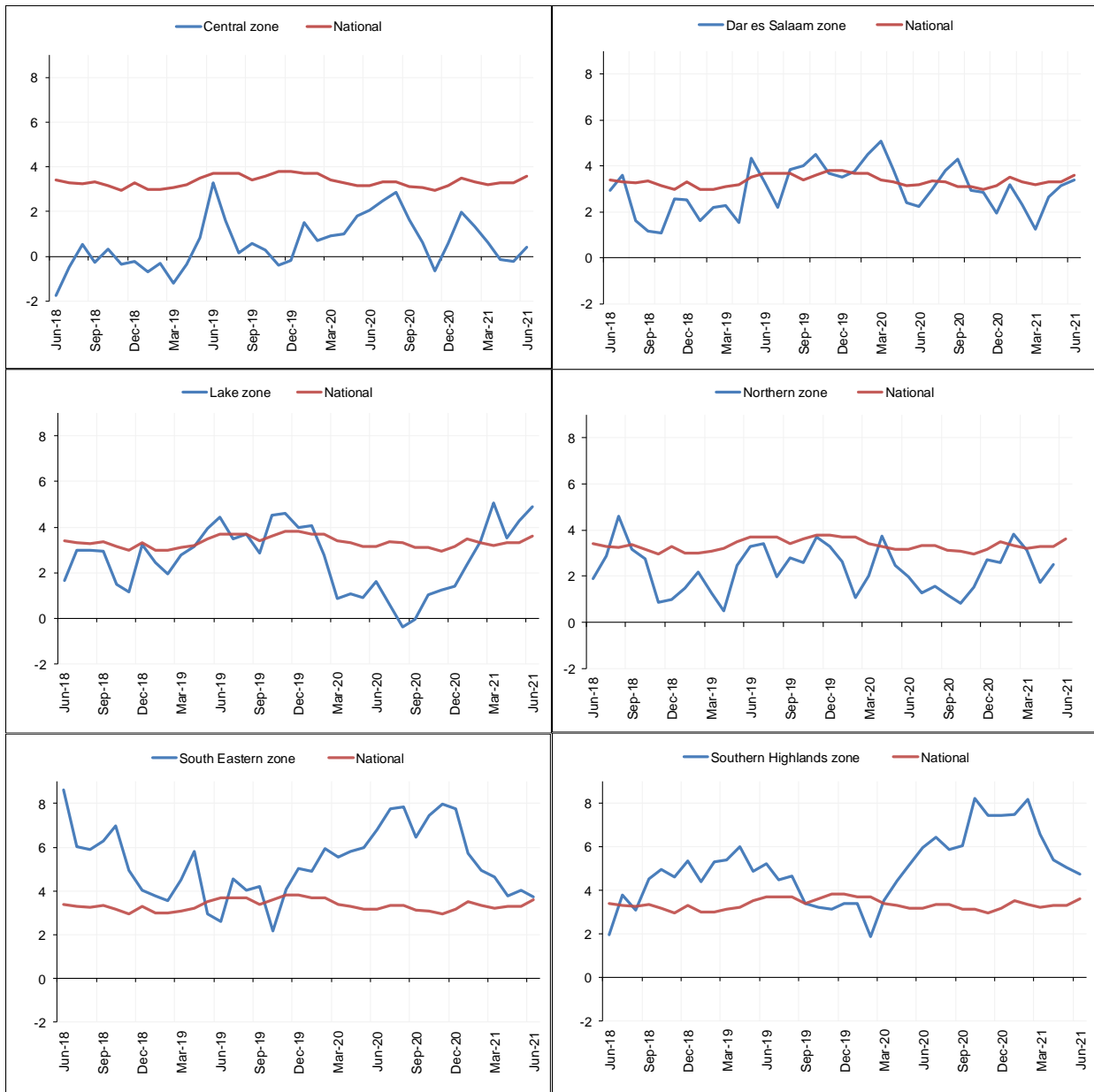

1.3 Wholesale Prices of Food Crops

Average wholesale prices of selected food crops² were lower in 2020/21 compared with prices in the preceding year, save for finger millet, beans and sorghum (**Table 1.4**). The decline was associated

with improved food supply in the market. The increase in prices of finger millet, beans and sorghum was due to low supply following unfavorable weather for the crops in major producing regions.

2.0 FOOD SUPPLY SITUATION

Food supply was generally satisfactory throughout 2020/21 following good harvests in the 2019/20 crop-season, with few reported incidents of food shortage in some districts.



2.1 Food Production and Requirements

All zones recorded increase in food production, except Dar es Salaam zone³. The production was 18.4 million tonnes, higher than the level produced in 2019/20 by 3.9 percent. Out of the total production, 7.8 million tonnes were non-cereals, while 10.6 million tonnes were cereals, of which 6.9 million tonnes was maize and 2.6 million tonnes of rice. This amount was above the estimated requirement for 2021/22 by 3.6 million tonnes, leading to a food Self-Sufficiency Ratio (SSR) of 125 percent (**Table 2.1**). All zones recorded a surplus with SSR of 120 percent or above, except Dar es Salaam and Northern zones.

2.2 Food Stock at the National Food Reserve Agency

Food stock⁴ held by the National Food Reserve Agency (NFRA) amounted to 107,357.4 tonnes at the end of June 2021 compared with 52,698 tonnes in the corresponding period in 2020 (**Table 2.2**). During the year under review, the Agency purchased 58,813.4 tonnes of cereals from farmers to replenish its stock and released 4,189.1 tonnes to Prisons Department, the World Food Program and Ministry of Agriculture Training Institute (MATI). Southern Highlands and South Eastern zones recorded the highest level of food stock, holding 55.3 percent and 19.6 percent of the total stock, respectively.

³ Dar es Salaam zone sources food from surplus producing regions as food production is not the major economic activity.

⁴ The stock of food comprises of maize (92.6 percent), paddy (6.3 percent) and sorghum (1.1 percent).

3.0 SECTORAL PERFORMANCE

3.1 Agriculture

3.1.1 Cash crop procurement

Overall, volume of selected cash crops procured during the 2020/21 crop season was lower than in the preceding season, save for tobacco and coffee which recorded increase of 18,582.1 tonnes and 13,262.0 tonnes, in that order (**Table 3.1**). The decrease was more observed in cotton whose volume dropped by 64.8 percent owing to excessive rains and farmers switch to cultivation of alternative crops, including rice. Noteworthy, some cash crops, such as cashew nuts and cotton whose

production was only in specific regions, are now gradually gaining space in other regions, owing to strategic initiatives by the Government and other key stakeholders.

3.1.2 Livestock

The livestock sub-activity continued to perform impressively, with the value of livestock sold in registered markets rising by 28.6 percent to TZS 1,875.6 billion from the value recorded in the preceding year. All zones recorded improvement, save for Dar es Salaam zone (**Table 3.2**). This outturn was partly associated with higher demand from neighboring countries. The value of cattle, which accounted for 89.5 percent of the total value of sales rose by 27.2 percent, driven by increase in both price and number of cattle sold. Lake, Central and Northern zones accounted for the largest shares of sales.

3.1.3 Fisheries

The value of fish sold in registered markets was lower than in the preceding year, mainly explained by unfavorable weather condition that partly led to rising in water levels that affected fishing activities in major lakes. Fish worth TZS 418.1 billion were traded in the registered market in 2020/21, lower than in the previous year by 7.7 percent (**Table 3.3**). Lake zone accounted for 53.5 percent of the total value.

3.2 Manufacturing

Manufacturing activity continued to register improvement. The value of selected manufactured commodities increased to TZS 10,608.8 billion from TZS 9,393.1 billion in 2019/20, with all zones recording increase, except Lake zone. This performance was mostly underpinned by expansion of market outreach, especially in neighboring countries. The decline observed in Lake zone was associated with impact of COVID-19 that reduced demand of some of the products in domestic and international markets, in particular for tea and coffee. In terms of contribution, Dar es Salaam zone accounted for 53.4 percent of the total value of selected manufactured goods, followed by Northern and South Eastern zones (**Table 3.4**).

3.3 Mining

The value of minerals recovery increased by 16.9 percent to USD 2,586.2 million (**Table 3.5**). This improvement was partly explained by continued use of mineral market centers, which have increased transparency, fair business environment and easy market accessibility by small-scale mineral producers, particularly for gold and gemstones. Overall, the growth in value was driven by rise in volume and price of gold in the world market. Lake zone accounted for the largest share in total value of minerals extracted, at 76.5 percent.

3.4 Tourism

Number of visitors and earnings⁵ from tourist attraction sites⁶ across all zones decreased by 38 percent and 20.5 percent to 991,614 and TZS 151.7 billion, respectively, in 2020/21 compared to the preceding year. The decrease was on account of measures taken to contain COVID-19 pandemic, which included travel restrictions. Notable increase in the number of visitors and earnings in South Eastern zone was due to establishment of Nyerere National Park in 2019 from Selous Game Reserve, which facilitated the recording and reporting of visitors in the zone.

3.5 Energy

Electricity generated domestically increased by 4.8 percent to 8,036,780.9 megawatts-hour (MWh), with all zones recording improvement. The increase was largely observed in thermal power plants in Dar es Salaam and Lake zones namely Kinyerezi II and Ubungo I; and Nyakato and Bukoba, respectively. The increase was also reported in Hydro power plants of New Pangani, Nyumba ya Mungu, Kidatu and Mtera following adequate rains. Installation of two new turbines at Mtwara gas fired electricity plant in December 2020, with installed capacity of 8.0 megawatts is expected to

improve power supply in the South Eastern zone (**Table 3.7**). Imported electricity during the period from Uganda and Zambia also increased by 14.5 percent to 125,503 MWh (**Table 3.8**).

Production of natural gas continued to improve in recent years, partly on account of increased demand by gas fired power plants operated by Tanzania Electric Supply Company Limited (TANESCO), manufacturing firms and households. Production of natural gas rose by 2.2 percent to 60,863.8 Million Standard Cubic Feet (MMSCF) from the volume registered in the preceding year.

4.0 GOVERNMENT REVENUE PERFORMANCE

4.1 Central Government Tax Revenue

Central government tax revenue amounted to TZS 17,847.3 billion in 2020/21, almost the same as in the previous year and was equivalent to 86.3 percent of the target (**Table 4.1**). All tax categories underperformed with taxes on local goods and services recording the least relative to the target owing to low consumption and production of some of consumer goods and services. Dar es Salaam zone continued to account for the largest share in total tax revenue, at 89.2 percent (**Table 4.2**).

4.2 Local Government Revenue Collection

Revenue collection by Local Government Authorities (LGAs) increased to TZS 711.1 billion in 2020/21 from TZS 664.0 billion in the preceding year, partly explained by enhanced use of electronic payment systems. Revenue collection was equivalent to 91.0 percent of the target. Dar es Salaam

zone accounted for 23.1 percent of total revenue collection, followed by Lake zone (21.1 percent) (Table 4.3).

5.0 TRADE

5.1 Cross Border Trade

Cross border trade balance increased to a surplus of TZS 7,435.6 billion from a surplus of TZS 5,799.1 billion recorded in 2019/20 (Table 5.1). Value of exports across Tanzania borders increased by 15.4 percent to TZS 10,802.5 billion from the value recorded in the preceding year, while imports fell by 5.4 percent to TZS 3,366.9 billion. All zones with cross-border trade activities registered a trade surplus. The increase in trade surplus in South Eastern, Northern and Lake zones was largely on account of a rise in exports of goods particularly cement, consumer goods, fertilizers, livestock and agricultural products, while that of Southern Highlands was explained by a decrease in imports of capital and other consumer goods. Northern and Lake zones contributed 71.1 percent and 30.7 percent of the total exports and imports, in that order (Table 5.1).

5.2 Ports Performance

Total volume of cargo handled through Tanzania's sea ports⁷ rose to 17,194.3 thousand tonnes from 16,912.3 thousand tonnes in 2019/20 (**Table 5.2**). The increase was largely associated with recovery of global supply chains, which were disrupted by the outbreak of COVID-19 pandemic. Cargo handling at all ports increased with the exception of Mtwara port whose decline was on account of low volume of cashew nuts and coal exports.

6.0 FINANCIAL SECTOR DEVELOPMENTS

6.1 Banks' Deposits and Lending

Banks continued to mobilize deposits across zones through various means including the use of agent banking services and mobile banking platforms. As a result, deposits grew by 13.3 percent to TZS 24,458.8 billion at the year ending June 2021, from the amount recorded in previous year. High growth in deposits was recorded in Northern, Lake and South Eastern zones. Meanwhile, Dar es Salaam zone accounted for 59.6 percent of total deposits (**Table 6.1**).

Bank loans extended to various economic activities by commercial banks grew by 9.0⁸ percent to TZS 17,549.8 billion at the end of June 2021 from the position registered in the corresponding period in 2020. Main drivers of the growth were Dar es Salaam zone that accounted for 60.4 percent of the increase, followed by Northern and Central zones at 13.6 percent and 11.3 percent, respectively. Dar es Salaam zone continued to hold the largest share of the outstanding loans, at 60.2 percent, while South Eastern zone was the least (3.5 percent) (**Table 6.2**). Personal, trade, social services, and agriculture, hunting, forestry and fishing activities dominated the loan portfolio, all together accounting for 77.3 percent of the total outstanding loans (**Table 6.3**).

6.2 Savings and Credit Cooperative Societies

Performance of Savings and Credit Cooperative Societies (SACCOS) slowed in terms of number, membership and outstanding loans (**Table 6.4**). The decrease was mainly associated with the ongoing exercise of registering SACCOS in line with Microfinance Act 2018.

7.0 ECONOMIC OUTLOOK

Economic performance in zones is expected to improve in 2021/22 following rollout of COVID-19 vaccines country-wide, policy measures adopted by the Bank to increase credit to the private sector and lower lending rates, and various ongoing strategic development projects and investments to support production activities, including power, roads and railways. The rolling out of vaccines and opening up of economies globally are also expected to improve tourism activities and enhance foreign exchange earnings. Pressure on headline inflation in some zones is projected to slowdown in the short term due to adequate food supply. Nevertheless, the slowdown in inflation may be dampened by the rising oil prices in the world market.
