PUBLIC NOTICE

OPERATIONS OF DECI (T) LIMITED

THIS IS TO INFORM THE GENERAL PUBLIC THAT DECI (T) LIMITED IS NOT LICENSED BY BANK OF TANZANIA (BOT) TO CONDUCT SUCH OPERATIONS IN THE COUNTRY.

THE PUBLIC IS ALSO NOTIFIED THAT THE CAPITAL MARKETS AND SECURITIES AUTHORITY (CMSA) HAS NOT GRANTED A LICENCE TO DECI (T) LIMITED TO OPERATE COLLECTIVE INVESTMENT SCHEMES IN TANZANIA.

IT SHOULD BE NOTED THAT PROMOTION AND PARTICIPATION IN ANY PYRAMID SCHEMES IS AN OFFENCE IN TERMS OF THE PROVISIONS OF THE PENAL CODE (AS AMENDED IN 2006).

WHILE AUTHORITIES ARE STILL CARRYING OUT INVESTIGATION TO ESTABLISH THE SCOPE AND NATURE OF OPERATIONS OF DECI (T) LIMITED IN THE COUNTRY, THE GENERAL PUBLIC IS WARNED TO DESIST FROM PARTICIPATING IN THE SCHEME OPERATED BY DECI (T) LIMITED.
