### NOTICE TO THE GENERAL PUBLIC

**NOTICE** is hereby given to the General Public that, the **DEPOSIT INSURANCE BOARD**, a body corporate existing under the provisions of section 37 (1) of the Banking and Financial Institutions Act, 2006 (the Act) of 2 Mirambo Street, 11884, Dar es Salaam has been appointed a liquidator of **KAGERA FARMERS COOPERATIVE BANK LTD** by the Bank of Tanzania in terms of the provisions of sections 41 (a) of the Act effective 4<sup>th</sup> January, 2018.
