The awards acknowledge efforts contributed by the individuals and businesses in enhancing financial inclusion in Tanzania, through encouraging expansion of financial services to unserved and underserved communities. The National Council shall issue all financial services and product awards from the banking, microfinance, capital markets, insurance and social security subsectors.

Purpose of the Awards

The purpose of the Tanzania Financial Inclusion Awards is to recognize individuals and entities that have demonstrated leadership in driving the development and implementation of best practices that address financial inclusion challenges in designing, implementing and advocating high-impact financial inclusion initiatives, programs, products, services, policies and regulations in Tanzania.

Guiding Principles

The principles guiding these awards include objectivity, fairness, inclusivity, impact, excellence, and collaboration. These criteria ensure that the awards are distributed fairly and equitably, focusing on initiatives with significant, sustainable impact on financial resilience and well-being among marginalized populations.

Scope

The awards target individuals and entities from banking, microfinance, social securities, insurance, and capital markets sub-sectors, Non-Governmental Organizations (NGOs) and participants from non-financial corporations from sectors such as manufacturing, tourism, transportation, wholesale and trading, agriculture, communications and information, as well as the sports and games industries making substantial contributions towards advancing financial inclusion in the country.

Specifically, the awards shall cover Disproportionate excluded segments, Fintech Innovations, Financial Literacy and Complaint Resolution, Financial Inclusion Research and Advocacy, and Policies and Regulatory Innovations.
